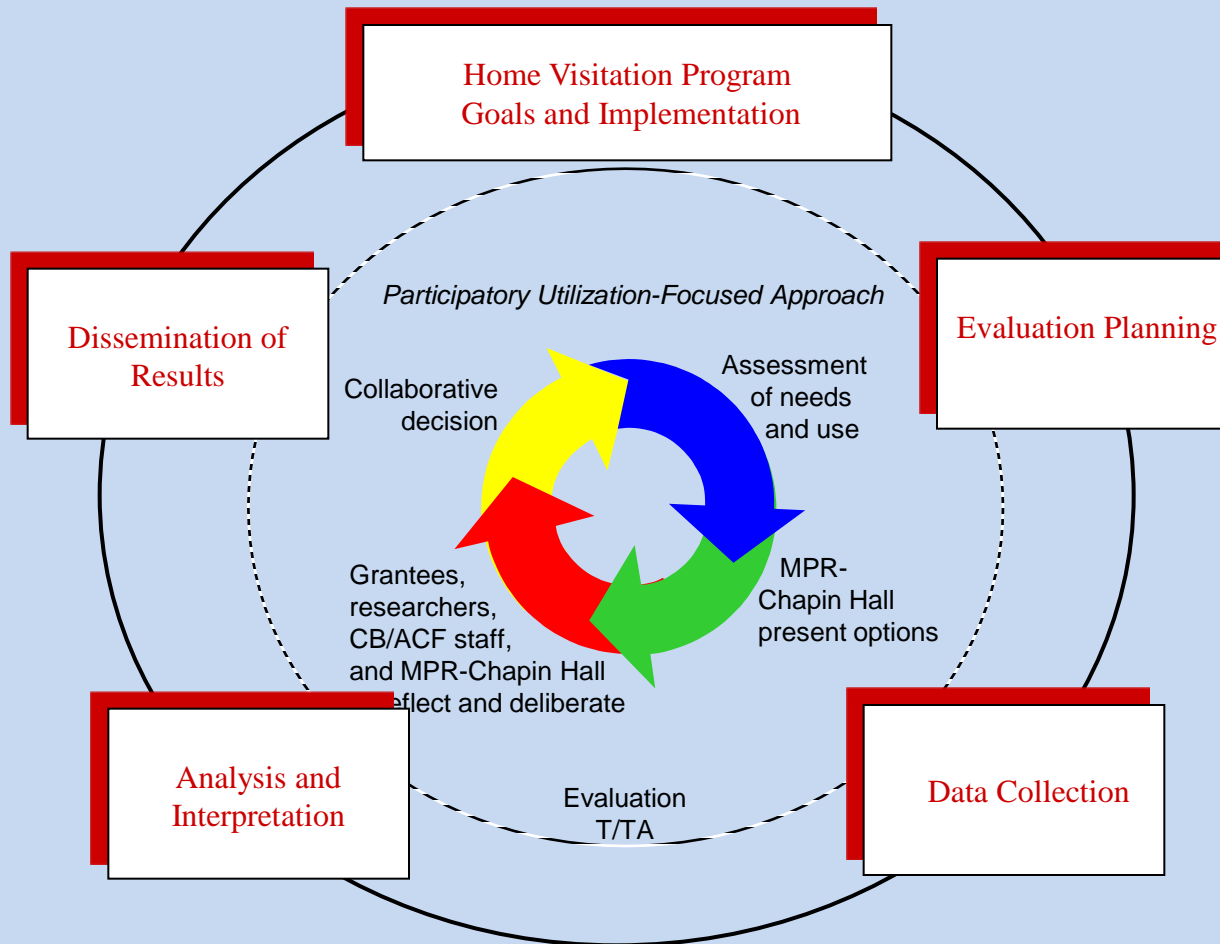

Evaluation Design Process

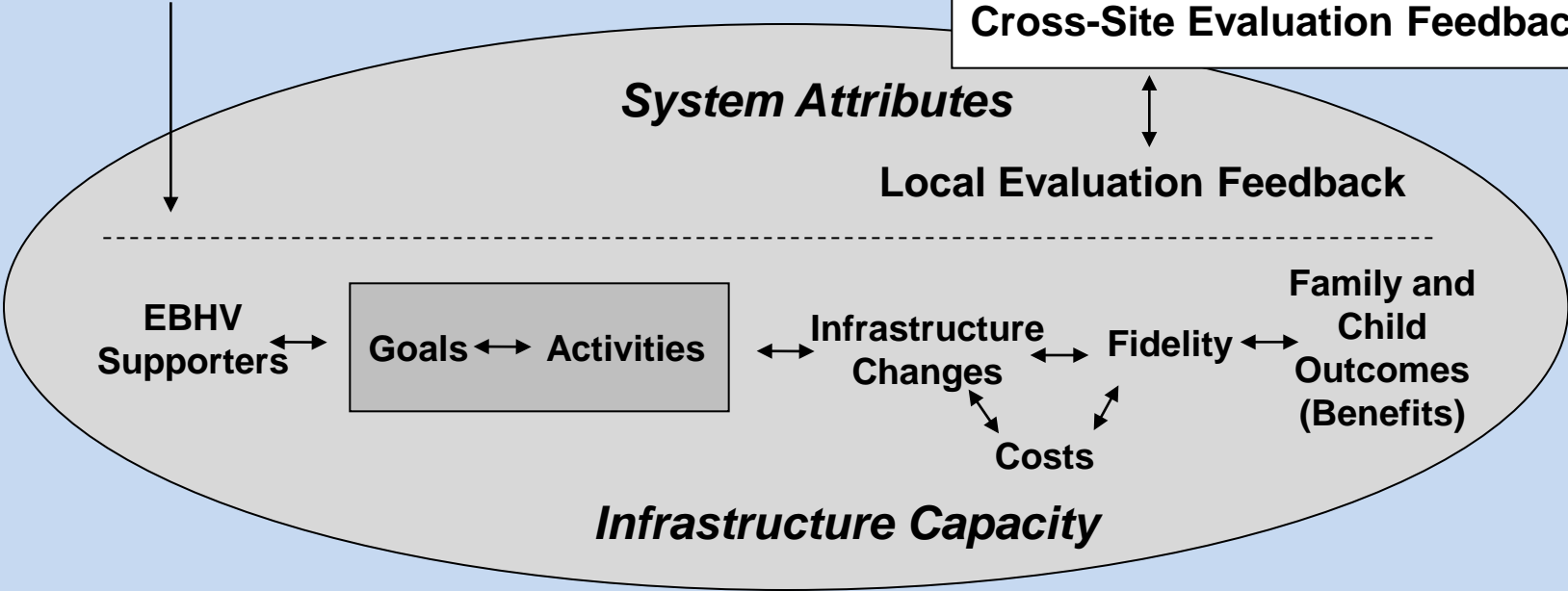
- Based on domain calls, identify measures

Overview of Proposed Design

- **Common framework across grantees to examine outcomes in each domain: Systems, fidelity, cost, family and child**
- **Identify common indicators of the evaluation domains**
- **Data collection is based on grantees' local evaluation goals**



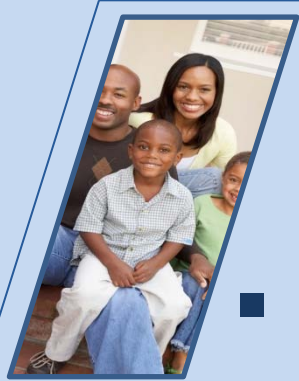
Systems Domain: Focus

- Infrastructure capacities to support grantees' infrastructure goals for fidelity, scale up, and sustainability
- Collaborative relationships among actors working on infrastructure goals across multiple systems levels
- Change over time in grantees' logic models for systems change



Fidelity Domain: Focus

- The extent to which an intervention is implemented as intended by its designers
- All intervention components and activities were implemented
- They were implemented in the proper manner



Family and Child Outcomes: Focus

- Parental risk and protective factors for child maltreatment
- Indicators of child maltreatment
- Child outcomes, such as behavioral problems or improvements in behavior



Cost Domain: Focus

- The resources devoted to delivering an effective EBHV program, as well as the essential infrastructure for supporting it
- The true cost of the program and related support



Process Study: Focus

- Context in which each grantee operates
- Influence of context on grantees' progress in evaluation domains
- Implementation of grant initiative
- Challenges and barriers encountered

Proposed Research Questions

Systems Domain: Research Questions

- How did grantees, working through different systems, build infrastructure capacity to support implementation with fidelity to evidence-based home visiting models, scale up of high-fidelity interventions, and sustainability of high-fidelity interventions after the grant funding ended?
- What infrastructure changes occurred?





Fidelity Domain: Research Questions

- Were the home visiting programs implemented and delivered with fidelity?
- To what extent did the grantees modify the national model to “fit” their target populations and local service delivery context?
- What contextual factors were associated with fidelity of implementation?



Family and Child Domain: Research Questions

- Do EBHV programs improve family and child outcomes when programs are implemented in the “real world” and supported by investments in infrastructure?
- How do effects vary across the different target populations grantees are working with and across program models?



Family and Child Domain: Research Questions (cont.)

- How did grantees identify their intended outcomes; how and for what reasons did grantees adjust their perspectives on achieving these outcomes as the initiative matured?



Cost Domain: Research Questions

- What are the total costs of delivery and support of the home visiting programs during a typical operating year?
- What does each program cost per participating family?



Cost Domain: Research Questions (cont.)

- How are costs allocated across key program components?
- How do costs vary by key program features and contexts?



Cross-Domain Research Questions

- Are systems and change in those systems related to fidelity?
- Are greater investments (costs) related to greater fidelity?
- How do costs vary among grantees focusing on different systems change activities?
- What contextual factors were found to be barriers or facilitators to systems change and fidelity?



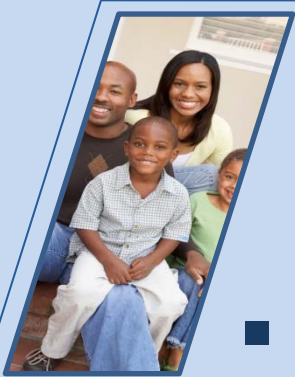
Process Study: Research Questions

- What are the key characteristics of EBHV grantees?
- How did grantees plan and implement their EBHV projects?
- What is the context in which EBHV grantees planned and implemented their projects?
- What are the facilitating factors or barriers to the overall planning and implementation of the EBHV project?



Process Study: Research Questions (cont.)

- What initial and ongoing training and essential infrastructure support did EBHV grantees receive from their national program models?
- What TA did grantees receive from the Children's Bureau, its contractors, or other TA providers?
- How did grantees participate in the design and implementation of the cross-site evaluation?



Process Study: Research Questions (cont.)

- How did grantees identify their intended outcomes? How and why did grantees adjust their perspectives on achieving these outcomes as the initiative matured?

Proposed Measures and Analytic Approach



Background

- **Grantees collect the quantitative data for the cross-site evaluation**
 - Focus on a parsimonious set of indicators
- **Diversity among grantees**
 - Mixed methods approach



Systems Domain: Measures

- Actors and their relationships
- Activities by system level
- Expected short- and long-term infrastructure changes
- Successes, challenges, strategies



Systems Domain: Analytic Methods

- Change over time, subgroup analysis
- Network methods
- Qualitative analysis



Fidelity: Measures

- **Structural Indicators**
 - Caseload
 - Supervisory Levels
 - Service Dosage and Duration

- **Dynamic Indicators**
 - Systematic assessment of needs
 - Participant involvement in decision making
 - Cultural relevance



Fidelity: Analytic Methods

- Change over time, subgroup analysis
- Qualitative analysis of provider assessment of achieving and sustaining model fidelity
- Qualitative analysis of participant experiences



Family and Child: Measures

- **Child maltreatment**
 - Abuse reports, system involvement, foster care placements
 - Injuries, ER visits

- **Parent outcomes**
 - Substance use, Parent depression

- **Child Outcomes**
 - Developmental progress, behavior problems, immunizations



Family and Child: Analytic Methods

- Systematic review of evidence
- Qualitative analysis



Cost: Measures

- Total program costs
- Allocation of costs to program components



Cost: Analytic Methods

- Total program costs
- Average cost per family
- Cost per program component



Process Study Approach

- **Descriptive analysis of implementation of grant initiative**
- **Site visits**
- **Some data collection through progress reports and web-based system**
- **Qualitative analytic methods**
 - Triangulation
 - Theme identification

Challenges and Opportunities



Challenges

- **Grantee Burden**
 - Sites with multiple models and sites
- **Network relationships (Systems)**
- **Participant level experiences (Fidelity)**
- **Aligning measures (Family and Child)**
- **Consistent program components (Cost)**



Opportunities

- **Network Survey (Systems)**
- **Individual Level Data (Fidelity)**
- **Peer Learning Network**
 - **Special analytic interests (costs, family and child)**
